



2017-2018 Verification Worksheet – Dependent Student

Your **2017–2018** Free Application for Federal Student Aid (FAFSA) was selected for review in a process called **verification**. Federal Law states, before disbursing Federal Student Aid, we may ask you to confirm the information you reported on your FAFSA. To verify that you provided correct information, we will compare your FAFSA with the information on this institutional verification document along with any other required documents. If there are differences, your FAFSA information may need to be corrected. You and a parent, whose information was reported on the FAFSA, must complete and sign this institutional verification document, attach any required documents, and submit the Verification Worksheet, and other required documents to financial aid. If necessary, we may ask for additional information for clarification. If you have **questions about verification, contact the financial aid office as soon as possible so that your financial aid will not be delayed.**

C. Income Information to Be Verified

1. **Tax Return Filers** – **Important Note:** If the student or parent(s) filed, or will file, an amended 2015 IRS tax return, please contact your financial aid administrator before completing this section.

Instructions: Complete this section if the student and/or parent(s), filed or will file a 2015 income tax return with the IRS. *The best way to verify income is by using the IRS Data Retrieval Tool that is part of FAFSA on the Web. If you have not already used the tool, go to FAFSA.gov, log into the student’s FAFSA record, select “Make FAFSA Corrections,” and navigate to the Financial Information section of the form. There will be instructions to determine if the student and/or parent are eligible to use the Tool. It takes up to two weeks for IRS income information to be available for the IRS Data Retrieval Tool for electronic IRS tax return filers, and up to eight weeks for paper IRS tax return filers.*

In most cases, for electronic tax return filers, 2015 IRS income tax return information is available for the IRS DRT or the IRS Tax Return Transcript within 2–3 weeks after the 2015 electronic IRS income tax return has been accepted by the IRS. Generally, for filers of 2015 paper IRS income tax returns, the 2015 IRS income tax return information is available for the IRS DRT or the IRS Tax Return Transcript within 6–8 weeks after the 2015 paper IRS income tax return has been received by the IRS. Contact the financial aid office if more information is needed about using the IRS DRT or obtaining an IRS Tax Return Transcript.
